SCOPE OF CONTRACT: The Contractor shall provide the services to the Purchasing Agency as set forth in the Contract Documents.


PERIOD OF PERFORMANCE: From December 15, 2016 through December 14, 2021.

- (6) The Contractor's Price Quote dated December 2, 2016 and the following agreement, all of which documents are incorporated herein.

The eVA portal is the gateway for vendors to conduct business with state agencies and public bodies. All vendors desiring to provide goods and/or services to the Commonwealth shall participate in the eVA Internet e-procurement solution by completing the free eVA Vendor Registration. All bidders or offerors must register in eVA and pay the Vendor Transaction Fees specified below; failure to register will result in the bid/proposal being rejected.

Vendor transaction fees are determined by the date the original purchase order is issued and the current fees are as follows:

- a. For orders issued July 1, 2014, and after, the Vendor Transaction Fee is:
 - (i) DSBSD-certified Small Businesses: 1%, capped at \$500 per order.
 - (ii) Businesses that are not DSBSD-certified Small Businesses: 1%, capped at \$1,500 per order.

Negotiation Points

1. Will Tk20 provide two (2) free User Conference rep fees per year of the contract?

Tk20 Response: While we do encourage regular and consistent training, Tk20 can only offer Longwood University two (2) waived Unit Administrator Training registrations for the entire contract term. Tk20 is happy to extend an additional subsequent day of on-site training at Longwood University at no additional charge.

Longwood Response: Accepts Tk20 response.

2. Does Tk20 accept end user input on modifications to the Strategic Planning & Budget section?

Tk20 Response: Tk20 Product Management would love to work with administrators at Longwood University as we develop Strategic Planning and Budgeting. There are a couple of ways to get involved. First, it would be great to interview the appropriate person or persons as to what they do now, and what they would like to do using Tk20, so that we can develop budgeting with those needs considered. Tk20 Product Management is also willing to validate designs prior to bringing them to development. Both of these things are essential to us and the work that we do, so your desire to participate is welcomed and encouraged.

Longwood Response: Accepts Tk20 response.

Questions

1. How do upgrades occur?

- a. How often do upgrades occur?

Tk20 Response: Tk20 generally produces 2-3 releases each year which include featured enhancements and bug fixes.

- b. Are end users given advanced notice of upgrades and if so, how long before release?

Tk20 Response: Yes, system administrators are given advance notice of upgrades. Most of the time, this advance notice is several weeks in advance of a pending upgrade. Administrators must acknowledge and confirm a time to proceed with the upgrade (overnight from 1:00-6:00am EST) for the institution. In working with the Implementation team, Tk20 clients are generally made aware of these timelines through training communication. In addition, release notes are provided that highlight any changes in the product including new features, workflow changes, browser compatibility, and known issues.

- c. Can end users opt in/out of upgrades?

Tk20 Response: Yes, system administrators can opt out of upgrades due to scheduling concerns, however end users may experience issues with certain browsers in older releases. For example, Tk20 maintains compatibility with the most recent two versions of major 2 browsers during the development cycle including Google Chrome, Mozilla Firefox, Microsoft Edge (formerly Internet Explorer), and Safari. Most browser upgrades are automatic. Thus, an end user could experience browser-related issues in older versions of Tk20 due to a lack of compatibility. We typically find that all Tk20 client institutions are upgraded to new versions within an academic semester timeframe.

Longwood Response: Accepts Tk20 response.

2. Is Tk20 developing a click-of-button feature to move documents from assessment to accreditation repository?

Tk20 Response: This item is currently on our product roadmap, and we have taken Longwood University's interest into consideration for prioritization. We would love to prioritize this with Instant Insight Reports to ensure ease of access in relation to Accreditation Management. Again, our goal is to truly partner with you all in a very collaborative manner.

Longwood Response: Accepts Tk20 response.
