This Supplemental Agreement is entered into pursuant to the provision of the basic contract.

Description of Modification: To exercise the first optional five-year renewal term of the contract for the Assessment, Planning, Budgeting and Accreditation Management System under the terms and conditions of RFP#LU214-16-009 dated December 2, 2015. The term of the renewal is from December 15, 2021 through December 14, 2026. Pricing for the renewal term is provided in Quote #Q-13058-1 dated December 10, 2021 and included as an attachment to this CMA #4. Pricing for year one of the renewal term is Term 2 on Page 2 of 3. Term 1 on Page 1 of 3 is a prorated amount for the period April 1, 2021 to December 14, 2021 and is the result of adding a new product and realigning the billing cycles of all other licenses to that of the contract.

Except for the changes provided herein, all other terms and conditions of this contract remain unchanged and in full force and effect.


